

500W 4-CH Amplifier Kit For 2006-2013 Harley Street Glide Fairing with Rear Speakers

Installation and Operation Instructions

Product Description

This exciting new J&M 4-channel 500w amplifier kit has been design specifically for use in the 2006-2013 Harley® Street Glide with the Harley HK radio along with a second set of speakers (4 total) mounted in the rear saddlebag or trunk pod position.

This is a full range class G amplifier and is spec'd at 125watts RMS per channel X4 channels, (500w total) driven continuous into a 2 ohm load @ 14.4vdc, 70watts RMS continuous X4 channels into a 4 ohm load.

Amplifier mounts to the top of the custom made stainless steel bracket system, which has the slots in the bottom


section to properly relocate the Harley CB, XM sat radio or iPod modules, if installed.


Custom made plug-n-play wiring harnesses are included with this amplifier kit, top quality heavy gauge power/ground wires are used for the fused battery connection, along with all necessary mounting hardware & complete installation/operation instructions.


Amplifier itself measures 10\(^{5}\)/8" X 5" X 1\(^{5}\)/8".


Installation Instructions

- 1. Remove the outer fairing shell, seat, and fuel tank.
- 2. By following along the factory wiring harness, route the amplifier power harness from the fairing, under the fuel tank, and on to the battery. (removal of the fuel tank is necessary for proper installation)
- 3. Then route the rear speaker wiring harness along the same path as the power harness to the rear speaker mounting location.
- 4. After first disconnecting the negative battery cable from the battery, connect the positive (red) lead from the amplifier power harness directly to the positive post of the battery. Then connect the negative (black) lead from the power harness to the same bolt/stud on the frame that the negative battery cable is connected to. Then reconnect the negative battery cable to the battery. (**Figure A**) Do not connect the negative (black) lead from the amplifier to the negative post of the battery.
- 5. For models with a CB and/or a SAT Radio installed, disconnect and remove them from the top of the factory radio. (Figure B) Replace the factory retention screws back into the radio. For models without a CB or SAT Radio, continue with the next step.
- 6. Remove both the left and right forward radio mounting bolts. Loosen but do not remove both the left and right rearward mounting bolts. (Figure C)









- 7. Relocate the large plugs from the inside of the fairing braces to the outside of the fairing braces. **(Figure D)**
- 8. Remove the (4) rubber grommets from the top of the factory radio. **(Figure D)**





9. Remove the metal stud from the right side fairing brace with a rotary cutting tool. **(Figure E)**




10. Remove the speedometer and tachometer retaining cups and cut out 1/2" of material on the bottom of the cups to allow clearance for the amplifier to be installed. Reinstall the modified gauge retention cups. **(Figure F)** Note: The amplifier should be installed as far back as possible to avoid interfering with the outer fairing shell.



- 11. Position the J&M Amp/Bracket assembly above the radio and slide into position. (Remove tie-straps and re-position the factory wiring harness as needed to allow the amplifier to fit into place properly)
- 12. Replace the forward radio mounting bolts and then tighten all (4) of the mounting bolts. (Figure G)
- 13. Make Amplifier/Speaker connections according to diagram. (Figure $\bf H$)

Note: Speakers used with J&M amplifier kit must have an impedence rating of 2 ohms or greater (up to 16 ohms is acceptable).





REAR

FOR MODELS WITH A CB AND/OR SAT RADIO, CONTINUE WITH STEPS (14) THRU (16), FOR BIKES WITHOUT A CB OR SAT RADIO, PROCEED TO STEP (17).

- 14. Install the previously removed CB and/or SAT Radio modules into the J&M lower mounting bracket and secure using the (2) 8-32x1/4 screws provided. (these are the longer of the remaining screws) (Figure I)
- 15. Position the lower bracket assembly below the factory radio and secure using the (4) remaining 8-32x3/16 screws provided. (Figure J) (Remove and re-secure any factory wiring attached to the bottom of the radio using the tie-straps provided)
- 16. Re-connect the CB and/or SAT Radio harness and antenna connectors.
- 17. Test the system for proper operation before reassembling the fairing, realizing that full sound quality and fidelity will not be heard until the outer fairing shell is completely reinstalled.

Note: To activate the front/rear fader feature of your Harley HK radio, ask your dealer to reflash the audio system for front/rear fade.
